Documentation

A written Health & Safety Policy is required by all business, except those with less then 5 employees, but even then, they are still required to have arrangements in place for managing health and safety. Policies are made up of three sections:

- 1. Policy Statement one page document signed by the director responsible for health and safety
- 2. Organisation and Responsibilities *structure of the business and the responsibilities each job role has for health and safety*
- 3. Arrangements the bulk of the document which details how health and safety is managed in relation to the activities of the business

Qualitative Face Fit Testing

Employers have a duty to ensure that respiratory protective equipment (RPE) provided is adequate and suitable. This is checked by carrying out Face Fit Testing, to ensure the wearer is properly protected from inhaling unwanted dusts, fumes or vapours.





We can attend your site or premises to carry out face fit testing. Operatives will need to have the mask they intend to use, so that this can be tested to make sure there is a proper fit that is stopping harmful particles getting in.

Prior to the testing taking place, we issue guidance for the operatives, so that they know what to expect. This also helps in dealing with those with limited spoken English, as we can translate the guidance into the required language.

Testing takes approximately 15 minutes per person from start to finish.

Note: Face Fit Testing can only be carried out on those that are clean shaven on the morning of the test. No smoking, eating or drinking within 30 minutes of the test, or the result may be affected.
